

BOOKING NOTES/TERMS

Maranatha Tours (Euro) Ltd

01. Please make deposit cheques payable to MARANATHA TOURS. The deposit will be held against final payment of your Holiday.
02. Kindly note that final payment is required around 10 weeks before departure from the UK - you will be invoiced accordingly.
03. Other than a material price change, if you cancel your booking before final invoicing, you may forfeit 50% of your deposit to cover airline cancellation charges.
04. If you cancel your booking in writing after final payment, we reserve the right to apply the following cancellation charges:
More than 56 days before departure date, deposit returned;
40-55 days before departure date, 30% cancellation charge;
22-39 days before departure date, 50% cancellation charge;
21 days to departure date or after, 100% cancellation charge.
05. Insurance is strongly recommended - if taking this, please enclose your remittance with deposit - your cover note will be sent with receipted deposit:
Insurance is compulsory, if not taking ours, you will be kindly required to supply proof of cover.
06. Visas to enter Israel are granted automatically to British (EU) passport holders.
07. British (EU) passport holders require passports valid for the dates of travel and for least for 6 months after the return date.
08. Final departure flight details along with other helpful information, will be sent to you approximately 10 weeks before departure from the UK.
09. There are no medical requirements to enter Israel.
10. All prices are based on the exchange rate of the UK Pound (£) to the US Dollar (\$) at 1.45 and will be capped at this base rate. At the time of final invoicing if the Pound has gained value against the stated currency, we will apply a discount of £23 for every 5 points Pound increase in the exchange rate against the US Dollar and this would be reflected in your invoice.
11. If you are in doubt about any of the above details or wish clarification on any point, please make contact with Angellight office or the Maranatha office at the addresses shown on this Booking Form.

Your Financial Protection

When you buy an ATOL protected flight or flight inclusive holiday from us you will receive an ATOL Certificate.

You agree to accept that in those circumstances the alternative ATOL holder will perform those obligations and you agree to pay any money outstanding to be paid by you under your contract to that alternative ATOL holder. However, you also agree that in some cases it will not be possible to appoint an alternative ATOL holder, in which case you will be entitled to make a claim under the ATOL scheme (or your credit card issuer where applicable).

If we, or the suppliers identified on your ATOL certificate, are unable to provide the services listed (or a suitable alternative, through an alternative ATOL holder or otherwise) for reasons of insolvency, the Trustees of the Air Travel Trust may make a payment to (or confer a benefit on) you under the ATOL scheme.

You agree that in return for such a payment or benefit you assign absolutely to those Trustees any claims which you have or may have arising out of or relating to the non-provision of the services, including any claim against us, the travel agent (or your credit card issuer where applicable). You also agree that any such claims may be re-assigned to another body, if that other body has paid sums you have claimed under the ATOL scheme.
